

## Terms of Service

Last Updated: October 21, 2024

Please read these Terms of Service ("Terms") carefully. BY USING THE SERVICE AND THE SITE, YOU AGREE TO THESE TERMS. IF YOU DO NOT AGREE, DO NOT USE THE SERVICE OR SITE.

### Services

- **Services and Websites.** Trucking42.school and Dispatch42.school (referred to, as applicable, as "Trucking 42 school" and "Dispatch42.school", the "Service", "we" or "us") provides online video courses include:

a) Access to an online platform containing educational materials such as video lessons, assignments, and additional resources.

b) Access to a virtual assistant available 24/7 to address questions course-related.

Trucking42.school and Dispatch42.school are owned and operated by Trucking42 Inc, a Florida Limited Liability Company.

- **Customer.** As a customer of the Service or a representative of an entity that is a customer of the Service, you are a "Member" according to this agreement (or "you"). You represent that you have full power, capacity and authority to accept these Terms on behalf of yourself or your employer.
- **Account Requirements.** To set up an account and use the Service you must:
  - Be 18 years of age, or the age of majority in your province, territory or country, to become a Member. Individuals under the age of 18, or applicable age of majority, may utilize the Service only with the involvement of a parent or legal guardian, under such person's account and otherwise subject to these Terms.
  - Provide your legal full name, valid email address, zip code, and any other information we request to complete your account-signup process.
  - Provide us with one or more Payment Methods. "Payment Method" means a current, valid, accepted method of payment, as may be updated from time to time and which may include payment through your account with a third party.
  - Personally and manually create your account without using any automated means, except for any auto-complete feature offered by your internet service provider. A third party may not create an account for you and you must not allow any third party to use your information to create an account.

- **Account Ownership.** The member who created the account and whose Payment Method is charged (the "Account Owner") has access to and control over the account and is responsible for any activity that occurs through the account. To maintain control over the account and prevent anyone from accessing the account, the Account Owner should maintain control over access to the Service and not reveal the password or details of the Payment Method associated with the account to anyone. Account owners are not allowed to share their account, log-in or any other access related credentials with any other party unless explicitly stated otherwise in the details related to the specific plan they purchased. Absent an explicit multi-user authorization, all accounts are intended for single-use only. You are responsible for updating and maintaining the accuracy of the information you provide to us relating to your account. We can terminate your account or place your account on hold in order to protect you and/or Trucking42.school or Dispatch42.school. You must immediately notify us of any unauthorized use of your account. We will not be liable for any loss or damage from your failure to comply with this security obligation.

## Payment

- **Billing.** Trucking42.school and Dispatch42.school may offer the Service through a variety of billing methods, which include, but are not limited to, one-time fee, one-time subscriptions, monthly recurring

subscriptions, and annual recurring subscriptions ("Subscription"). Trucking42.school and Dispatch42.school will bill you on the date you subscribe to the Service ("Subscription Date"), and will continue to bill you in accordance with your selected Subscription until you cancel the Service. You must cancel your Subscription at least one day prior to the next billing date to avoid a Subscription renewal. Fees will be billed to your Payment Method on the calendar day corresponding to the Subscription Date. Subscription fees are fully earned upon payment. In some cases your payment date may change, for example if your Payment Method has not successfully settled or if your Effective Date began on a day not contained in a given month. You shall pay all fees or charges to your account in accordance with the fees, charges, and billing terms in effect at the time a fee or charge is due and payable. If auto-renewal is enabled for the Services you have subscribed for, you will be charged automatically in accordance with the term you selected. If, in our judgment, your purchase constitutes a high-risk transaction, we will require you to provide us with a copy of your valid government-issued photo identification, and possibly a copy of a recent bank statement for the credit or debit card used for the purchase. We reserve the right to change products and product pricing at any time. We also reserve the right to refuse any order you place with us. We may, in our sole discretion, limit or cancel quantities purchased

per person, per household or per order. These restrictions may include orders placed by or under the same customer account, the same credit card, and/or orders that use the same billing and/or shipping address. In the event that we make a change to or cancel an order, we may attempt to notify you by contacting the e-mail and/or billing address/phone number provided at the time the order was made.

- **Payment Methods.** To use the Service you must provide one or more Payment Methods. You can update your Payment Methods by going to the "Account" page of our Website. Following any update, you authorize us to continue to charge the applicable Payment Method(s). You authorize us to charge any Payment Method associated to your account in case your primary Payment Method is declined or no longer available to us for payment of your subscription fee. You remain responsible for any uncollected amounts. If a payment is not successfully settled, due to expiration, insufficient funds, or otherwise, and you do not cancel your account, we may suspend your access to the service until we have successfully charged a valid Payment Method. For some Payment Methods, the issuer may charge you certain fees relating to the processing of your Payment Method. Check with your Payment Method service provider for details.
- **Cancellation.** You can cancel your membership at any time, and you will continue to have access to the Service through the end of your pre-paid billing cycle. - **Fixation of Interactions.** All client communications are documented and securely stored.
- **Refunds.** Refunds are only available prior to accessing the course on the platform. "Accessing the course" is defined as successfully logging into the platform and completing the first session. Refunds are not provided after access

is granted, except for partial refunds related to mentorship services if included in the purchased package and not delivered to a satisfactory standard.

- **Money Back Guarantee.** Notwithstanding Section above, if you contact our Customer Support department within 3 days of your original sign-up, you are eligible for our Money Back Guarantee. To receive your money back, you must contact our Customer Support team online at [course@trucking42.school](mailto:course@trucking42.school) no later than 3 days following your original sign-up and ask for a refund. Any contacts made after that 3 day period will not be eligible for our Money Back Guarantee. Only

your first purchase is subject to the Money Back Guarantee; renewal orders are not eligible for the Money Back Guarantee under any circumstances.
